Stomagienics, Inc. has created this privacy statement in order to demonstrate our firm commitment to privacy. The following discloses our information gathering and dissemination practices for this website.

Stomagienic, Inc. automatically tracks how the website content provided is used. This tracking allows us to gain a better understanding of potential areas for improvement so as to continually improve the relevance of and accessibility to, the content we provide. To this end, Stomagienics, Inc.. may at times deposit certain pieces of information called "cookies" on a visitor's computer. These "cookies" allow a more detailed level of tracking to fine tune our usage reports. However, should you have "cookies" disabled on your machine, then you continue to have exactly the same access to Stomagienics content as with 'cookies' enabled, it will only result in slightly less accurate usage figures for our own internal reports.

This usage information will only be used within Stomagienics, and our relevant partners, to increase the quality of content, service and support to our visitors. Some of this information may be made public from time to time, however it will only be in an aggregate, non-personally identifiable form, such as how many visitors have been to this website.

Personal Information

You may voluntarily share personal information on this website. In general, Stomagienics, Inc. will use such information only for internal purposes. We do not sell such information to external third parties, except in conjunction with a corporate sale, merger, dissolution, or acquisition. Personal information can be used to send you information about our company. In some places on this website, you can elect to receive information and products. In these instances, we may provide your personal information to vendors solely for the purpose of assisting you with ordering requested products. If we share personal information with third parties, we do not allow them to keep, disclose, or use this information with others except for the purpose of providing the services and products we ask them to provide. Anonymous browsing on Stomagienics, Inc. websites

Stomagienics, Inc. does not gather any personal information or information related to any individual via cookies. The information collected is gathered using a cookie ID (a number of approx. 20 characters) plus a country ID. This means that Stomagienics will only be able to use statistical data that relates to groups of people but will in no way be able to identify any individual or information or site activity related to any individual.

Personal information is only gathered via forms on the site, in which the user actively enters information and sends this to Stomagienics. In this case, Stomagienics still respects and obeys the laws and regulations relating to gathering and storing personal information.

You can choose not to allow cookies (read more in the section "How to block and avoid cookies"). This way you remain completely anonymous to Stomagienics and the Google Analytics tool we use.

General definition of a cookie

A cookie, also known as an HTTP cookie, web cookie, or browser cookie, is used for an origin website to send information to a user's browser and for the browser to return the information to the origin site. The information can be used for authentication, identification of a user session, user's preferences, shopping cart contents, or anything else that can be accomplished through storing text data on the user's computer.

What is the gathered information used for?

The cookie-collected information is used for helping Stomagienics understand its visitors and how they engage with the website. All information is anonymous, but the cookie tracks trends like the click stream of users. The user-supplied information, which requires the user to actively sign up, is used for sending requested information like product information, financial information, and job information.

Advertising and targeting cookies

These cookies are used to deliver advertisements more relevant to you and your interests. They are also used to limit the number of times you see an advertisement and/or receive an email newsletter from Stomagienics, as well as help measure the effectiveness of an advertising campaign. They are usually placed by advertising networks with the website operator's permission. They remember that you have visited a website and this information is shared with other organizations such as advertisers' email newsletter agencies. Quite often targeting or advertising cookies will be linked to site functionality provided by the other organization.

What information is gathered?

Stomagienics gathers two types of information from its webpages. The information gathered by cookies, and the information supplied by the users who fill out various forms for more information, sample orders, etc.

The information gathered by the cookie is defined by Google Analytics and is information such as:

- Time of current site visit.
- If and when the site was last visited by the user.
- From which site did the user come to the Stomagienics website (note that first party cookies do not share information across sites).
- IP address, which again is used to identify information like country, state, city (this is known as IP geolocation). The cookie does not collect information like name, email, or other address or billing information.
- Also, the Google Analytics Terms of Service clearly prohibits any Analytics customers from gathering information that associates personal information with Google Analytics information.
- The information the users supply varies from form to form depending on purpose. Be aware that these forms
 are created in accordance with global and local laws and regulations.

Protection of personal information

Stomagienics ensures that all user specific information is stored in accordance with local and international laws and regulations.

Information about cookies and other technology

When you visit our Website, we send one or more cookies – small text files containing a string of alphanumeric characters – to your device. We use both session cookies and persistent cookies. A session cookie disappears after you close your browser. A persistent cookie remains after you close your browser and may be used by your browser on subsequent visits of our website. Your web browser may provide you with some options regarding cookies. We use cookies and automatically collected information to: (i) personalize our Website and the services provided via our Website, such as remembering your information so that you will not have to re-enter it during your use of, or the next time you use, our Website and the services provided via our Website; (ii) provide customized advertisements, content, and information on the basis of profiling; (iii) monitor and analyze the effectiveness of our Website and the services provided via our Website and third-party marketing activities on the basis of profiling; (iv) monitor aggregate site usage metrics such as total number of visitors and pages viewed; and (v) track your entries, submissions, and status in any promotions or other activities offered through our Website and the services provided via our Website (profiling). Tracking technology

(profiling) also helps us manage and improve the usability of the Website, (i) detecting whether there has been any contact between your computer and us in the past and (ii) to identify the most popular sections of the Website.

Social Media Networks. Third parties, including Facebook, may use cookies, web beacons, and other storage technologies to collect or receive information from the Website and elsewhere on the internet and use that information to provide measurement services and target ads. When Does Stomagienics, Inc. Collect Information From Me?

While shopping or taking advantage of services available from us, we may ask that you provide personal information. For example, we request personal information when you:

- Participate in a sweepstakes, promotion or survey
- Contact us with a question or concern

Does Stomagienics, Inc. Share My Personal Information With Others?

Stomagienics, Inc. does not sell or rent your personal information to third parties.

We may need to share your personal information with certain third parties such as our agents, service providers and other representatives acting on our behalf for limited purposes. For example, we may share personal information with third parties to perform services on our behalf such as:

Does Stomagienics, Inc. Use Cookies, Other Technologies Or 3rd Parties To Collect Information?

Cookies and Clickstream Technology

A cookie is a small data file that a Web site or e-mail may send to your browser, which may then be stored on your hard drive. Our Website and e-mails use cookies to create a more personalized shopping experience for visitors to our site. Cookies simulate a continuous connection — they let us "remember" information about your preferences and session and allow you to move within areas of our Web sites without reintroducing yourself.

Stomagienics, Inc. may choose to use a third party to place cookies on your computer to collect non-personally identifiable information. Although our cookies may contain a unique user ID, they do not collect or store any of your personally identifiable information.

You may choose to set your Web browser to not accept cookies. If your cookies are disabled, you can still view our site, but you may not be able to create an account or make payments.

Our Web server automatically collects clickstream information such as the address (or URL) of the Web site that you came from before visiting our site, which pages you visit on our site, which browser you used to view our site, and any search terms you may have entered on our site, among other things.

Our Web site may also use other technologies to track which pages of our Web sites our visitors view. This anonymous clickstream data helps us understand how visitors use our Web site.

Third-Party Ad Providers

Our Web sites may use third-party service providers to serve ads on our behalf across the Internet and to analyze Web site traffic on our behalf. They may collect anonymous information

about your visits to our Website, and your interaction with our ads. These companies may use technologies like those outlined above to measure the effectiveness of ads and e-mails. They may also use information about your visits to this and other Websites so that we can provide advertisements about goods and services.

No personally identifiable information is collected in this process. We may share anonymous information with this service provider in an aggregate form, for purposes of analysis and improvement of our site.
